BOOKING TERMS AND CONDITIONS

The following booking conditions form the basis of your rental contract with us. They set out our respective rights and obligations and we recommend you should read them carefully

- 1. Booking your rental:** To make your booking you must complete our booking form. A signature by the party leader is needed (who must be over 18) on behalf of all persons travelling. The party leader will be responsible for all payments due in respect of the rental booked. The booking form must be forwarded to us with payment of 20% of the total cost. If booking is within 8 weeks of departure full payment must be made.
- 2. Your Contract** A binding contract between us comes into existence when we dispatch our confirmation letter. This contract and all matters arising from it are governed by English law. In the unlikely event of a dispute between us, we both agree the matter will be dealt with by the courts of England and Wales.
- 3. Payment** A deposit of 20% of the rental cost must be made before we can confirm your rental.
After we have dispatched your deposit confirmation no further reminders will be issued. Remainder of payment is due eight weeks prior to rental period.
If full payment is not received by this time we have the right to treat your booking as cancelled by yourself.
The deposit is non refundable.
We advise cancellation insurance is taken out.
If any payment is dishonoured we reserve the right to charge an administration fee of £20.
- 4. Security Deposit** A security deposit of £250 is required against each booking. This will be refunded in full after the rental period following inspection of the property for breakages or damage to its contents.
- 5. Rental period** Will commence at 4pm on the day of arrival and end at 10Am on the day of departure.
- 6. The maximum number** of guests should not exceed 12
- 7. The client agrees to be a considerate tenant,** to take good care of the property and to leave it in a clean and tidy condition at all times. Although a light clean is included in the price, we reserve the right to make retention from the security deposit to cover additional cleaning costs if the property is left in an unacceptable condition.
- 8. Report to the owners** without delay any defects in the property or breakdown in the equipment or machinery in the property or grounds.
- 9. We will not be responsible** to you for any temporary defect or stoppage of public services to the property, nor in respect of any equipment, machinery or appliances. Nor for any loss, damage or injury which is the result of any adverse weather conditions, riot, war strikes or other matters beyond our control. We are also not liable for any loss, damage or inconvenience caused to or suffered by you if the property should be destroyed or substantially damaged before the start of the rental period. In such an event we within seven days of notification to you, refund all sums previously paid in respect of the rental period.
- 10. Under no circumstances shall our liability** exceed the amount paid to us for the rental period.

11. **Use of ski and other sports equipment** You will agree to use the ski locker provided to store skis/boards. You also agree to leave ski/board boots in the hallway bathroom and not to wear them at any time in the property.
12. **Behaviour** You agree to act in a manner so not to cause disturbance, distress or injury to those resident in the neighbouring properties
13. **Towels and linen** At least one clean hand and one clean bath towel will be provided per guest. Clean bed linen is provided on arrival, this will include sheets, pillowcases and quilt cover. You are requested to leave all linen and towels together in a convenient area upon departure.
14. **Smoking** – is not allowed in the property – for safety reasons it is only allowed in the grounds outside the property.
15. **Pets** Are not allowed in the property under any circumstances
